

Astronomy

1) Documents required at the recruitment application stage:

The documents should be loaded directly into the Online Application System (IRK).

- a) **reference letter for the candidate** issued by a research fellow holding at least the academic degree of doctor habilitated or being an employee of a foreign university or research institution, who has significant achievements in academic issues related to the discipline of astronomy;
- b) the candidate's **curriculum vitae (CV)**, with particular emphasis on academic achievement and information on the level of knowledge of English;
- c) **diploma supplement or official transcript of the grades**, and in the absence thereof, a copy of the index book or of another document containing the course names and the grades received, accompanied by information on the grading scale used;
- d) **a certificate of average grade** for first-cycle studies completed and a certificate of average grade for master's studies excluding the last year of studies (in the case of complementary master's studies, the average grade for the first year of these studies should be provided);
- e) **confirmation from a research fellow** (who holds a scientific title, or the academic degree of doctor habilitated, employed in the unit where the training program is implemented) **of the possibility of providing supervision** of the candidate in the event of admission to the Doctoral School;
- f) optional: **a copy of the master's thesis** or its outline if it is not completed;
- g) **short description of scientific interests** (max. 2000 characters).

In the event of the persons referred to in Article 186, section 2 of the Act:

two opinions confirming the high quality of their research work and the high level of advancement of such work, issued by: a research fellow holding at least the academic degree of doctor habilitated or being an employee of a foreign higher education institution or a research institution, who has significant achievements in academic issues related to the curriculum.

Any document submitted in a language other than Polish or English must be accompanied by a certified translation into Polish or English.

2) Documents required for entry:

- a) the original OAS application printed out from the system, containing a photograph;
- b) a photocopy and the original for inspection of:
 - i. a diploma or other document of graduation of a higher education institution abroad entitling the holder to undertake education in order to obtain the degree of doctor in which it was issued, recognized as equivalent to the relevant Polish master's diploma, and if, by the date of entry, the candidate does not yet hold a master's diploma document,
 - ii. a certificate issued by the higher education institution confirming that the candidate has passed the diploma examination, containing information on the right to take up education in order to obtain the degree of doctor in whose system the institution operates, with the grades given from the diploma examination, from the diploma thesis and on the diploma (for graduates of the second degree studies also a certificate containing these grades from the completed first degree studies);
- c) originals of all other documents provided at the registration stage in the form of a scan;
- d) for inspection: **identity document** (passport in case of foreigners).

In the event of exposure to harmful, noxious or hazardous factors, the applicant will, at the time of registration, be referred for a medical examination by an occupational medicine physician. The candidate shall be obliged to deliver, within the time limit set by the Co-ordinator of the Education Programme, a medical certificate confirming the absence of contraindications.

Higher education diplomas awarded abroad should:

1. bear an apostille clause if the issuing country is covered by the Convention abolishing the requirement legalization for foreign public documents, done at The Hague on 5 October 1961 (Journal of Laws of 2005, No. 112, item 938) or
2. be subjected to legalization, in other cases.

In particularly justified cases, at the request of the Co-ordinator of the Education Programme, on the basis of a written justification submitted by the Candidate to Doctoral School, the Director of the Doctoral School may waive the requirement to submit an apostille or legalize university diplomas or other documents.

Any document submitted in a language other than Polish or English must be accompanied by a certified translation into Polish or English.

IMPORTANT:

A person admitted to the doctoral school begin education and acquire doctoral student rights upon taking the oath.
